

MARKET WATCH

Market Performance

Despite the Amman Stock Exchange's strong start to 2008, this week witnessed an unpleasant drop in prices, reminiscent of the 2006 'stock market bubble bursting' which had seen the General Index tumble down dramatically both locally and regionally. Echoing the downturn in the global indices this week, the Index began to decline on Monday, falling by 2.4%. With an overwhelming feeling of déjà vu, and fears of a repeat of the devastating 2006 market correction, investors began to sell shares in a blind panic, in a bid to realize what profits they could and cut losses. This caused the General Index to drop to a low of 7671.33 points on Tuesday, falling below the 8,000 point barrier it broke earlier this year. This represented a significant decline of 7.46% since last week's closing, and a whopping 4.0% since the prior day. On Wednesday, with an improvement in regional markets, the Index started optimistically, rising by 1.5%. Eager to realize profits, a selling trend took over, leading to a further 0.5% decline by the day's end. The declining trend continued through to the end of the week, despite the recovery in a number of shares' prices, slipping by a further 0.3% to close at 7,671.26. Nonetheless, year-to-date, the Index still registers an overall increase, with a gain of 2.0%.

In terms of share performance, 134 of the 188 companies traded this week experienced a decline in share price, while 44 companies' share prices defeated the market and rose.

Sector Performance

Trading activity was also rather subdued, with an average daily volume of 19.5 million shares compared to 20.2 million last week. The average daily value traded also decreased, registering at JD 64 million, 15% lower than that of last week. The Arab Bank (ARBK) ranked top of the list in terms of value traded for the second consecutive week, while the Housing Bank for Trade and Finance (THBK) squeezed its way onto the top rankers, outperforming Jordan Telecom (JTEL). The rest of last week's top performers remained unchanged.

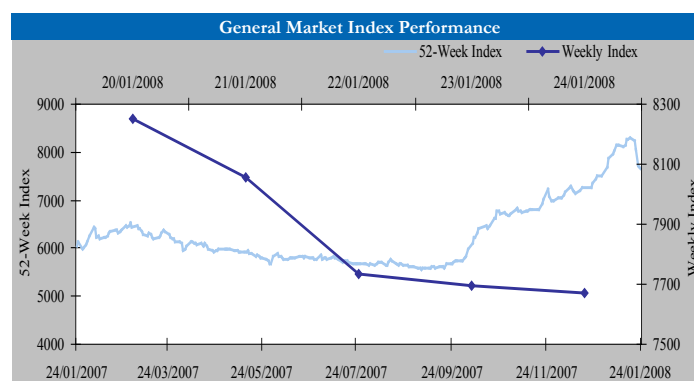
With a trading value of JD 150.56 million and a volume of 61.86 million shares, the Services sector came out top compared to the remaining sectors, followed by the Industrial sector in terms of volume of shares traded, and by the Banking sector in terms of value traded.

The sector indices decreased across the board, with the Industry sector index falling by 10.7% compared to last week. Second in line was the banking sector index which dropped by 6.6%, dragged down primarily by the decline in prices of the sector heavyweights, the Arab Bank and the Housing Bank, whose share prices dropped by 7.2% and 7.0%, respectively.

The fall in the Services and Industrial sectors, on the other hand, amounted to 6.2% and 0.5% respectively.

Block Trades

Block trades amounted to JD 15.37 million this week, representing a total of 7.45 million shares, with the largest block deal being carried out on the stock of Al Faris National Company for Finance and Investment (CEBC) with 2.5 million shares traded at a value of JD 2.1 per share. Of the other deals for this week, the most significant were for South Electronics (SECO), with 5 block deals amounting to 1.5 million shares, all of which were at JD 1 per share, giving a total traded value of JD 1.5 million, and two block deals on the shares of Union Arab Investment Company (UAIC), with 1.5 million shares traded for a total value of JD 4.05 million.

CORPORATE NEWS

- The **Arab Bank (ARBK)** announced the opening of two new branches in Algeria, taking up the total number of branches there to four.
- The **Jordan Commercial Bank (JOGB)** opened its 28th branch in Karak this week, representing its 25th branch in the Kingdom.
- The 13.49 million rights issues of **Societe Generale Banque-Jordanie (MEIB)** were listed on the Amman Stock Exchange on Wednesday, at a price of JD 1.85 per share under the symbol R0042, while the new reference price of the MEIB shares was JD 3.12 per share. The MEIB stock ended its first day of trading following the rights issue at JD 3.20 per share, and the rights issue at JD 1.85 per right.
- The **Arab Real Estate Development Company (ARED)** changed its name to the Arab Group.
- **Jordan International Investment Company's (JIIG)** Board of Directors resolved to raise the Company's paid-up capital from JD 10 million to JD 15 million through a public subscription.
- The **Jordan Press Foundation / Al Ra'i (PRES)** will recommend, in its General Assembly, to distribute 100% cash dividends to its shareholders, the highest rate to be distributed in the history of the Company. The Jordan Press Foundation's net profits after tax for 2007 amounted to JD 11.6 million, while its revenues registered at JD 30.8 million, up 25.7% compared to the year prior.
- **Future Arab Investment Company (FUTR)** has announced the purchase of 20% of the Syrian Jordanian Free Zone Company, a limited liability company with a paid-up capital of JD 1.5 million.
- **Contempro For Housing Projects Company's (COHO)** Board of Directors resolved to distribute 12.5% cash dividends, equivalent to JD 750 thousand, to the Company's shareholders. They also agreed to allocate 10% of the Company's profit to the statutory reserve and another 10% to the voluntary reserve.
- The Social Security Investment Unit (SSIU) signed an agreement worth JD 135.8 million to purchase the Government's remaining 11.6% stake in the **Jordan Telecom Group (JTEL)**. The 29.13 million shares were purchased at a price of JD 4.6 per share, thereby raising the SSIU's ownership in the Group to 29%.
- **Jordan Steel (JOST)** has announced its preliminary results for the year 2007, with net profits before tax and provisions of JD 6.74 million. The Company's Board of Directors resolved to recommend during their General Assembly the distribution of a 22% cash dividend.

- The Board of Commissioners of the Securities Depository Commission approved the registration of the 2.9 million additional shares of the **Ready Mix Concrete and Construction Supplies Company (RMCC)**, for the purpose of raising the Company's capital, through the allocation of 2.9 million shares in favour of the Arab Bahrain Cement Holding Company. The shares will be issued at a price of JD 5 per share, representing a par value of JD 1 and a premium of JD 4.

MACROECONOMIC NEWS

- The Finance and Economic Committee at the House of Parliament and the Ministry of Finance declared a JD 50 salary increase for both retired and non-retired employees of the civil and military sectors whose salaries fall below the JD 300 mark, and an increase of JD 45 for those whose salary lies above the JD 300 mark.
- Statistics issued by the Central Bank revealed that remittances from Jordanians working abroad increased by 17.9% during the first ten months of last year compared to the same period of 2006, to reach JD 2.02 billion.
- The Central Bank announced the issuance of the first Treasury bills for 2008 on the 31st of this month, to the value of JD 100 million with a maturity of one year.
- The Customs Department is expecting a decrease of JD 9.5 million in their revenues, following the enforcement of the Cabinet's decision to exempt 13 goods from customs this year.
- The new prices that will be applied to oil derivatives were announced this week. Fuel prices will be increased by 16%, with unleaded fuel reaching 742 fils per litre, compared to its current price of 640 fils. Super fuel prices will be increased from 605 fils to 702 fils per litre, while regular fuel will reach 499 fils per litre compared to 430 fils. Diesel and kerosene prices will reach 515 fils per liter, up from 315 fils, while the price of gas cylinders will leap from a current price of JD 4.25 to JD 7.50.
- Steel Rebar prices continue to rise, reaching JD 680 per tonne. Steel prices increased by 35% per tonne over the past couple of months, and approximately 5% since the start of this month.
- Jordan's oil bill for 2007 registered at JD 1,998 million, of which the value of crude oil purchased amounted to JD 1,554 million. The average price of crude oil in 2007, inclusive of transportation costs and other expenses, reached USD 74.08 per barrel.
- The statutory reserves for licensed banks at the end of 2007 amounted to JD 842 million, while their excess reserves, including overnight window deposits, registered at JD 336.4 million, as per the Central Bank of Jordan.
- Advertising expenditure registered a 28% increase last year, according to IPSOS-Stat Jordan, reaching USD 275 million, compared to USD 215 million in 2006. This increase in advertising has been attributed to the rising levels of competition in the market, particularly in the telecommunications and banking sectors.
- The Jordan Investment Board opened a representative office in the United Arab Emirates, with the aim of supporting economic and political relationships, in addition to attracting further foreign investments to the Kingdom. Moreover, the volume of United Arab Emirates' investments benefiting from the Investment Promotion Law amounted to USD 100 million, distributed over the industrial and hotel sectors.
- The Civil Service Consumer Corporation has prepared its strategic plan for the years 2008-2011, which entails geographical expansion and increased services throughout the Kingdom. The Corporation plans to open 5 more stores and 8 shops this coming year.
- Preliminary statistics issued by the Central Bank for the month of November 2007 highlighted a decline in the total area in Jordan permitted for construction to reach 760.7 thousand square meters, the lowest area recorded since January 2006, which registered at 733.2 thousand square meters. On the other hand, the number of construction permits granted registered a 7% increase, reaching 1,731 permits. The total number of construction permits granted during the first 11 months of 2007 compared to the same period of 2006 registered a 4% increase, while the licensed area declined by 4%. Amman still claims the lion's share of both residential and non-residential activities for the first 11 months of 2007, with Zarqa following in terms of non-residential activity, and Irbid following in terms of residential activity. However, despite the high level of residential construction activity, Irbid has witnessed a substantial 60% drop in demand for apartments since the start of this year, due primarily to the increase in construction costs translating into an increase in apartment prices.
