

MARKET WATCH

Market Performance

As the end of the month approaches, coinciding with the end of the first quarter, the Amman Stock Exchange was witness to a selling frenzy in a bid to realise profits and minimize losses as a sharp downturn overwhelmed the market during the first three days of this week. Holders of market heavyweight stocks, struggling to sell off their holdings, resorted to selling off stocks held in smaller companies to obtain liquidity, bringing about an overwhelming decline in the Index to reach a low of 7,883 points on Tuesday. A whopping 49 of the companies traded touched on their 52-week low this week, rendering the prices of a sizeable portion of the market seemingly attractive. This drew investors back in to rebuild positions again, taking advantage of the low prices, which pulled up the Index back over the 8,000 point mark to end the week at 8,161.4 points, albeit, still 3% lower than last week's close.

The average traded value also declined compared to last week, dropping by 45% to JD 61.65 million. Moreover, 118 of the 198 companies traded this week experienced a decline in share price. But it was not bad news for all; the announcement of outstanding profits by Emmar Investments, which amounted to JD 8.02 million, positioned it as our top gainer for this week.

Jordan Petroleum Refinery and Royal Jordanian continued to dominate our lists of most active stocks in terms of both volume and value of shares, while the Arab Bank and Jordan Phosphate Mines made it to our top five in terms of value traded, once again.

Sector Performance

The dominance of share price declines meant that all sector indices ended in the red for the second week running, with the Banking Sector Index dropping by 3.08% due primarily to the decrease in share prices of the Bank of Jordan and the Jordan Islamic Bank, with declines of 8.3% and 5.7% respectively. The Industrial Sector followed, with a 2.90% drop.

The Services Sector claimed the bulk of the trading volume with 53.2 million shares traded, followed by the Industrial Sector, with 20.2 million shares. In terms of sector P/Es, the Insurance Sector saw a drop from 19.33 times last week to 16.96 times, due to the strong financial results of the Middle East Insurance Company, which increased its earnings per share, which pulled down its P/E.

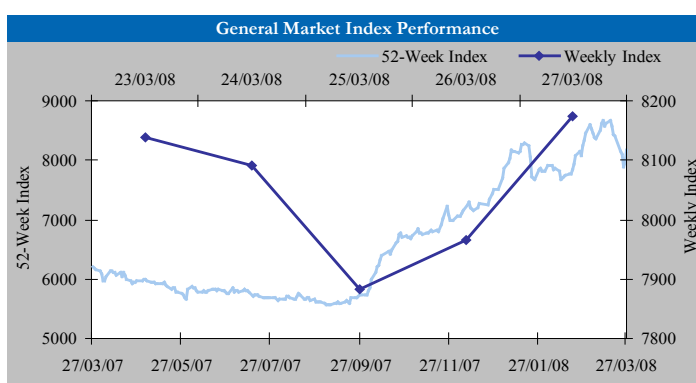

first, the Arab Real Estate Development (ARED) had two block deals, with 585.5 thousand shares traded for a total value of JD 1.33 million. The second company was Jordan Central (JOCE) with three blocks trades for a total of 243.1 thousand shares at a price of JD 2.54 per share.

CORPORATE NEWS

- The **Arab Banking Corporation (ABCO)** announced their financial results for 2007 with net profits before taxes amounting to JD 15.2 million. Total assets and shareholders' equity registered at JD 601 million and JD 77 million respectively, while customer deposits reached JD 368 million compared to JD 252 million in 2006, and credit facilities increased by 11% compared to 2006.
- The international rating agency, Fitch Ratings, has assigned a Long-Term Rating of BB- for the **Jordan Islamic Bank (JOIB)**, a Short-Term Rating of B, a Support Rating of 3 and an Individual Rating of C/D.
- The General Assembly of **Arab Jordanian Insurance Company (ARGR)** approved the distribution of JD 1.23 million as stock dividends equivalent to 14% of paid-up capital, thereby increasing their paid-up capital from 8.78 million shares/JD to 10 million shares/JD.
- **Al Amal Financial Investment Company (AMAL)** resolved to raise its paid-up capital from 7.5 million shares/JD to 15 million shares/JD through a private subscription at a price of JD 1 per share, in addition to distributing 13% dividends.
- The **Real Estate Investment Company / AQARCO (REIN)** announced its financial results for 2007, with net losses of JD 681.56 thousand compared to profits of JD 228.91 thousand in 2006. Total assets also declined, dropping by 8.7% to JD 8.57 million.
- The Board of Directors of **International Arabian Development and Investment Trading Company (INMA)** resolved to recommend to their General Assembly the distribution of 43% stock dividends, in order to raise the Company's paid-up capital from JD 7 million to JD 10 million.
- The Amman Stock Exchange announced that the shares of **Al Tajamouat for Touristic Projects (MERM)** will be moved from the secondary market to the primary market as of Wednesday this week.
- The **Jordan Duty Free Shops (JDFS)** announced their financial results for 2007 with net profits amounting to JD 4.15 million, equivalent to 83% of its paid-up capital. The Company also announced the distribution of 70% cash dividends.
- The General Assembly of **Jordan Petroleum Refinery (JOPT)** approved the settlement agreement signed with the Government last month regarding the basis of the Company's operations in the post-concession period, to include the import and distributing services of oil derivatives in the Kingdom.
- The **Jordan Steel Company's (JOST)** General Assembly approved the Board's recommendation to distribute 22% cash dividends. The Company's net profits amounted to JD 5.67 million compared to JD 3.84 million in 2006, an increase of 47.6%.
- The Board of Directors of the **Ready Mix Concrete and Construction Supply Company (RMCC)** resolved to recommend to their General Assembly the distribution of 17% cash dividends, in addition to raising the Company's capital from 15 million shares/JD to 25 million shares/JD through the distribution of stock dividends of two free shares for every 3 shares held from

- The **Jordan Chemical Industry Company (JOIC)** resolved to recommend to their General Assembly the distribution of 25% cash dividends.
- The **Jordan Paper and Cardboard Factories (JOPC)** announced their financial results for 2007 with net profits declining to JD 432,946 from JD 647,278 in 2006. Total assets and shareholders' equity registered at JD 19.82 million and JD 10.53 million respectively.
- The General Assembly of the **Arabian Steel Pipe Manufacturing Company (ASPMM)** approved the distribution of 15% cash dividends.
- **Al-Qaria Food and Vegetable Oil Industries (UCVO)** announced their financial results for 2007 with profits before tax and provisions amounting to JD 737.6 thousand, an increase of 155% compared to 2006. Total shareholders' equity increased to JD 5.1 million compared to JD 4.9 million in 2006.
- The **Universal Modern Industries' (UMIC)** General Assembly resolved to distribute 7% cash dividends.
- **Darat Jordan Company** announced that the number of subscribers in its IPO reached around 10 thousand and the total subscribed shares amounted to 30.42 million shares. 13.1% of issued shares were allocated to subscribers.
- The **Rum Tourism Company** announced their financial results for 2007 with net profits amounting to JD 356.67 thousand. The Company also announced the increase of their paid-up capital to JD 7 million through a public subscription, the additional shares of which will be listed on the Amman Stock Exchange next week.

MACROECONOMIC NEWS

- The Head of the Parliament Financial and Economic Committee announced that there is no intention to impose sale taxes on trading in stocks on the Amman Stock Exchange.
- Preliminary statistics issued by the Insurance Commission of Jordan revealed a 9% increase in the insurance premiums to reach JD 54.8 million at the end of February 2008 compared to JD 50.2 million for the same period in 2007. This increase was attributed to the 8% rise in premiums on General Insurance segments, which reached JD 48.8 million compared to JD 45 million. Life insurance premiums increased by 13% to register at JD 6 million compared to JD 5.3 million for the same period last year.
- The Insurance Commission of Jordan raised the minimum required capital for new insurance and reinsurance companies from JD 8 million to JD 25 million in an effort to reduce the number of companies in the sector with insufficient capital that are unable to properly serve the local market.
- The Executive Privatisation Commission estimated the required government expenditures on infrastructure in the Kingdom to be 750 million dollars annually, or 6-7% of GDP. Because the Government can only provide around \$100-200 million per year there is ample opportunity for the private sector to cover part of the capital required. To that end, there is an intention to develop a special fund for investments in infrastructure.
- According to the Department of Statistics, Gross Domestic Product (GDP) at constant prices for 2007 registered at 6%, while GDP at current prices registered at 12.3%. Moreover, the rate of inflation as measured by the gross domestic product deflator for 2007 amounted to 5.97%.
- Four investment companies have applied to participate in the Jordan Petroleum Refinery's fourth phase expansion project. These are the Nour Kuwaiti Company, an Emirati company, an Indian company, and the investor, Michael Dagher, representing himself. The fourth phase is expected to cost USD 1.3 billion, and the receiving of tenders for the project is expected to commence within one month.
- The Government terminated the agreement with the Pakistani–Chinese–Jordanian consortium that had won the bid to construct and operate the Amman Zarqa light railway due to terms of the agreement not being met by the agreed upon date.

- The number of passenger of Royal Jordanian increased by 22% last month compared to the month of February 2007, with 169 thousand passengers compared to 140 thousand.
- The “fuel support” cheque distribution mechanism revealed that the poverty percentage rate is substantially higher than official figures, with one third of Jordanian citizens living below the poverty line, with family incomes falling below JD 504 per month.
- The Minister of Planning announced the allocation of JD 2.5 million from the Ministry’s budget to support projects in Irbid.
- Steel factory owners reached an agreement on the selling price of steel in the local market, which will be fixed at JD 710/tonne plus 16% sales tax.
- The prices of vegetables increased by 40-120% despite expectations of a drop in prices following the early onset of summer weather. The price of one kilo of cucumbers doubled from 400 fils to 800 fils over the past two weeks, tomato prices increased from 250 fils to 550 fils/kilo, while lemon prices increased to JD 1.40/kilo compared to JD 1.00/kilo.
