

MARKET WATCH

Market Performance

This was another dark week for the Amman Stock Exchange with its General Index tumbling by 4.1% compared to the prior week's closing. With the week coinciding with the end of the month, the market saw a flurry of selling activity by investors in a bid to realise profits and close margin positions, which led the General Index to drop sharply on the first two days of trading registering a total decline of 209.4 points. On Tuesday, a minor recovery occurred with the market rising by 1.4%, only to drop again slightly on Wednesday and end the day 0.7% lower than its previous closing. On Thursday, however, the market recovered and registered an impressive 3% increase, ending the week at 2,656.7 points.

Liquidity levels were rather low this week despite the announcement of a 50 basis point decrease in interest rates, with the average daily trading value dropping by 10.8% to JD 26.91 million, while the average daily traded volume registered an insignificant increase from 10.75 millions shares last week to 10.95 million shares this week.

Our list of top gainers and losers presented a few surprises, with Shareco Brokerage ranking in first position with a 25.21% rise in share price, while United Arab Investors found itself in our top decliners list for the second consecutive week, with its share price falling from JD 1.39 last week to JD 1.09.

By the end of the week, only 45 companies out of the 199 companies traded experienced an increase, while 143 companies ended in the red. As a result, the market capitalisation and market P/E continued to decline standing at JD 23.64 billion and 11.65 times compared to JD 24.61 billion and 12.12 times of last week.

Sector Performance


The lion's share of trading went to the Services Sector, with 33.81 million shares traded for a value of JD 52.55. The Banking Sector followed with a total of JD 42.64 million, of which the Arab Bank contributed 72.4% at JD 30.89 million, ranking it in top position in terms of most active stocks in value of shares traded. The Industrial Sector, with a traded value of JD 34.50 million came next, and the Insurance Sector brought in the rear with a trading value of JD 4.87 million.

All indices ended in the red this week, with the Insurance Sector Index registering the largest decline of 5.8%, followed by the Banking and Services sector indices, which dropped by 5.4% and 4.5% respectively. The Industrial Sector experienced the lowest decline in its index, at 0.9%.

Block Trades

This was a quiet week for block trades, with only four deals taking place for a total value of JD 5.69 million. Two block deals were executed on the stock of the Industrial Development Bank (INDV) for a total of JD 4.55 million. Specialised Investment Compounds (SPIC) had 100 thousand shares traded at JD 5.09 per share, while the Arab Orient Insurance (AALI) had one block trade carried out on its stock, with 234,126 shares traded for JD 632,140.

CORPORATE NEWS

- The **Arab Bank (ARBK)** extended its buy-back of treasury shares for another 30 trading days after a month from receiving the approval of the Board of Commissioners of the Jordan Securities Commission.
- The Bank of Jordan (BOJX) signed a loan agreement with Jordan Mortgage Refinance Company (JMRC) with the aim of helping citizens to own residential property through mortgages granted by the Bank. Under the terms of the agreement, JMRC granted the Bank of Jordan an amount of JD 15 million with a maturity of one year to refinance the housing loans granted by the Bank.
- Four Jordanian banks, the Jordan Ahli Bank (JONB), Housing Bank for Trade and Finance (THBK), Jordan Kuwait Bank (JOKB) and the Jordan Islamic Bank (JOIB), have joined together to launch the Middle East Payment Services (MEPS), which is a company committed to issuing and accepting debit and credit cards.
- Shareco Brokerage (SHBK) announced its financial results for the first half of 2008 with net profits before tax amounting to JD 1.65 million, registering an increase of 177% compared to the same period of last year.

- Rum Tourist Transport (RUMM) signed an agreement with Global Investment House/Jordan, where Global will be the financial advisor and lead manager in the establishment of a charter airline company specialized in covering short haul destinations throughout Europe and the MENA region.
- The 5.7 million additional shares of **Bindar Trading and Investment Company (BIND)** were listed on the Exchange on Monday, thereby raising the Company's listed capital to 20 million shares/JD.
- The 1.125 million additional shares of Jordanian Expatriates Investment Holding (JEIH) were listed on the Exchange
 on Tuesday of this week. The new reference price for JEIH's shares was set at JD 0.65 per share, thereby raising the number
 of shares traded to 16.125 million.
- The Social Security Corporation (SSC) purchased 10.005 thousand shares of Arab Bank (ARBK) stock, 37.4 thousand shares and 4 thousand shares respectively of the Housing Bank of Trade and Finance (THBK) and Capital Bank of Jordan (EXFB), 40 thousand shares of Industrial Development Bank (INDV), 35 thousand shares of the Jordan Electricity Power Company (JOEP), and 30 thousand shares of Amlak Finance/Jordan (AMLK) this week, while it sold 127.4 thousand shares of the Arab German Insurance Company (AICGG).
- The Board of Commissioners of the Jordan Securities Commission announced:
 - The registration of the Central Bank's JD 36 million treasury bills with a maturity date of May 5th 2009.
 - The registration of the JD 50 million treasury bills with a maturity date of May 12th 2009.
 - The registration of the 32.2 million shares of United Iron and Steel Manufacturing Company following the

transformation of Company's legal description from a limited liability company to a public shareholding company.

MACROECONOMIC NEWS

- The Central Bank of Jordan declared a 50 basis points cut in key interest rates and bank reserves by 1% this week, in addition to reducing the re-discount rate from 6.75% to 6.25%, the repurchase agreement (Repo) rate from 6.50% to 6.00%, and the deposit window rate on the Jordanian Dinar from 4.50% to 4.00%.
- The Central Bank of Jordan announced the issuance of JD 100 million treasury bonds with a maturity date of May 26th, 2010.
- The Governor of the Central Bank of Jordan amended CBJ's instruction to banks regarding credit facilities in order to ease restriction on such facilities. CBJ extended the coverage period on bank overdraft accounts from 30 days to 90 days, as well as decreasing the movements on the overdraft account to two times per period instead of four times.
- Remittances from Jordanians living abroad reached JD 1.8 billion during the first eight months of 2008, an increase of 11.9% compared to the same period of 2007. Moreover, the Kingdom's foreign currency reserves rose by 22% during the first nine months of 2008 compared to the same period of 2007 to reach JD 7.76 billion.
- According to statistics issued by the Ministry of Tourism and Antiquities, tourism's income during the first ten months of 2008 reached JD 1.7 billion compared to JD 1.4 billion during the same period of 2007, registering an increase of 25%.
- The Government and its Sudanese counterpart signed 18 agreements along with one memorandum of understanding in order to strengthen cooperation between the two countries especially in the fields of agriculture, health and transportation.
- The Government and its Chinese counterpart signed five agreements, two of which are in the field of nuclear energy while the others are economical and educational agreements.
- The Ministry of Public Work and Housing, along with the Ministry of Transportation and Aqaba Development Corporation, and in collaboration with the private sector announced that they will establish infrastructure projects as well as road and transportation projects in the Kingdom with an estimated cost of USD 3.3 billion.
- The Minister of Planning and International Cooperation met with the Export-Import Bank of China on Sunday in order to sign a USD 29.3 million loan agreement where the latter will finance the military housing project established in Zarqa.
